

Actelion Pharmaceuticals Ltd, a Janssen pharmaceutical company of Johnson & Johnson, respects your privacy and wants you to be familiar with how we collect, use, and disclose information. This Privacy Policy describes our practices in connection with information that we or our service providers collect through the application (hereinafter the “**Service**”) operated and controlled by us from which you are accessing this Privacy Policy. We encourage you to read the full Privacy Policy before using this Service or providing any personal information. By providing personal information to us or by using the Service, you acknowledge that you have read and understand this Privacy Policy.

USE BY MINORS

The Service is not directed to individuals under the age of 18, and we request that these individuals not provide personal information through the Service. If your child has submitted Personal Information and you would like to request that such Personal Information be removed, please contact us as explained below under Contacting Us.

INFORMATION COLLECTION

The Service does not process Personal Information except to the extent mentioned below in section “Automatic Information Collection and Use”. We may combine the information you submit with other information we have collected from you, whether on or offline, including, for example, your purchase history.

SENSITIVE INFORMATION

The Service does not process sensitive information and we ask that you not send us, and you not disclose, any sensitive personal information (e.g., Social Security numbers, information related to racial or ethnic origin, political opinions, religion or philosophical beliefs, health or medical condition, sex life or sexual orientation, criminal background, or trade union membership, or biometric or genetic data for the purpose of uniquely identifying an individual) on or through the Service or otherwise directly to us.

AUTOMATIC INFORMATION COLLECTION AND USE

We and our service providers may collect certain information automatically as you navigate around the Service. We and our service providers may automatically collect and use the following information:

IP address: Your IP address is a number that is automatically assigned to your computer by your Internet Service Provider. An IP address is identified and logged automatically in our server log files whenever a user visits the Service, along with the time of the visit and the pages visited. Your IP address will be anonymized and not linked to you. Collecting IP addresses is standard practice and is done automatically through Google Analytics. We use IP addresses for purposes such as calculating Service usage levels, diagnosing server problems, and administering the Service. We may also derive your approximate location to a country level from your IP address.

Tracking case studies and outcomes: The information we will be collecting automatically will not be linked to you. It will be related to the case studies and questionnaires completed through the Service. This information collected automatically may include the number of clicks on the different pages in the Service, whether a user has scrolled to the bottom of the

page, whether the user has viewed all images displayed in the Service before assessing the outcome of the case study, the time spent to finish the case study, and whether the user has scrolled through the feedback after completing the case study. This information will be collected automatically because it will enable us to mark a case study as 'complete', to display the result of the case study on the app, and to track the correct and the wrong answers.

HOW WE USE AND DISCLOSE INFORMATION

We use and disclose information you provide to us as described to you at the point of collection. For the purposes of the Service we do not collect, process or disclose any personal information. We may use and disclose information we collect automatically as described above under "Automatic Information Collection and Use."

CHOICES AND ACCESS

We do not collect or process personal information other than the IP address through the Service. However, if you have a request with regards to any personal information that has been collected or processed by us or our affiliates, you can reach out to us in accordance with the 'Contacting Us' section below.

CROSS BORDER TRANSFER

Your data may be transferred to countries outside your country of residence, including the United States, which may have different data protection rules than your country. However, appropriate contractual and other measures are in place to protect your personal data when it is transferred to our group companies or to third parties in other countries.

Some countries outside the European Economic Area (EEA) are recognized by the European Commission as having an adequate level of data protection in line with EEA standards (the full list of these countries can be found [here](#)). For transfers from the EEA area to countries not considered adequate by the European Commission, we have ensured that appropriate measures are in place, including ensuring that the recipient is bound by EU standard contractual clauses to protect your personal data. RETENTION PERIOD

We exclusively collect your IP Address while you are using the Service.

We will retain it for as long as is necessary and permissible in respect of the purposes for which it was collected. The criteria for determining our retention periods include: (i) the length of time we have an ongoing relationship with you and are providing the Service to you; (ii) whether there is a legal obligation to retain it to which we are subject; and (iii) whether retention is necessary in light of our legal position (for example, in relation to applicable statutes of limitation, litigation or regulatory investigations).
